AMHC's therapy funds program offered 8 sessions of therapy for free to over 320 individuals in need, funding over 2500 hours of culturally responsive therapy. The therapist directory has over 3400 licensed Asian therapists, serving all 50 states, DC and US territories.

AMHC builds wide-reaching virtual community spaces to foster conversation, connection, and peer support around mental health. Led by Asian mental health professionals, Community Support Groups offer peer connection and guidance for the general public. Over 319 people attended support groups totalling 51 hours of peer support. AMHC's online discussion forum, Subtle Asian Mental Health, has over 61,000 members and provides a unique platform for discussing Asian mental health, validating cultural experiences, and sharing resources.
